Question #1

STH 42 Resurfacing Project
Gibraltar to Sister Bay
Bluff Lane to Country Walk Drive
Door County
A portion of the above project: Project ID and plat page 4140-19-21, page 4.02

To approve funding for the purchase of real estate acquisitions necessary for the STH 42 project not to exceed \$200,000. WisDOT has agreed to share costs to extend sidewalk from Windmill Lane to 500' north of Gibraltar Road as part of the upcoming STH 42 resurfacing project. The number of parcels affected is 15. As part of the agreement, the town will be required to purchase property for the sidewalk extension and associated items. Items associated with the sidewalk extension include curb, gutter, storm sewer, retaining walls, and pedestrian refuge islands.

Hwy 42 project not to exceed \$200,000 pursuant to \$60.10 (2)(e) of the Wisconsin State Statutes.

Question #2

To approve the purchase of Part of Gibraltar, Chambers Island T.31-32N.-R.26E North and South islands of Mackaysee Lake, State of Wisconsin Board of Commissioners of Public Lands, islands are located in Mackaysee Lake on Chambers Island, pursuant to §60.10 (2)(e) of the Wisconsin State Statutes.

The Door County Land Trust (DCLT) would like to partner with the Town of Gibraltar and the Chambers Island Nature Preserve Committee to purchase the 2 islands in Lake MacKaysee. The 2 islands are worth \$21,000. The Wisconsin Board of Commissioners of Public Lands needs to sell them and they can sell directly to a unit of government. The Land Trust as a nonprofit to purchase them would have to be part of the public bidding process.

The following is being proposed: the DCLT would provide the Town 100% funding for the purchase and all associated land acquisition costs. The Town would seek public approval to purchase the islands with 100% funding and transfer them to DCLT for long term ownership and management.
