Iove for the outdoors guided Vonnie and Dave Callsen to put down stakes permanently in Ellison Bay over 35 years ago. But for Dave, the urge to surround himself with nature has been a lifelong pursuit, beginning as a boy living in Madison.

"I grew up with friends who liked to go out in he country," he says. "When we were in grade school we'd camp out all by ourselves. No tents, we'd just lay down on blankets and sleep on the side of a hill." Vonnie adds, "Under the stars."

After their marriage and a move to the Chicago suburbs for Dave's management position at AT&T, the pull to live in Door County made itself known during family camping trips when their three children were young. "Our favorite place to camp was on the peninsula," Vonnie said. "It was then we pretty much decided we would move up here."

The couple built the family-run grocery, Main Street Market, in Egg Harbor in 1987. They value their home's rural setting on 25 acres as an antidote to the busy store.

"I like it here because of the wildlife and it's peaceful," Dave said. "The night skies are gorgeous here. You have a clear night in the winter or the summer, it doesn't matter, it's just great."

The couple's understanding of the value of wild places has grown from living in Door County and from their involvement with the Door County Land Trust. Dave served on the board for a number of years, holding many offices including Board President. "It was fascinating when I got on the board because I learned so much more," Dave says.

A lifestyle that includes the benefits of nature is something the Callsens have promoted with their children, grandchildren, and now greatgrandchildren, many of whom live on the peninsula. It is also something they feel is important to protect for future generations overall. Vonnie and Dave have shown their commitment by becoming members of the Land Trust's Legacy Circle.

"If you're going to leave something for those you leave behind, we always felt that what we do should be something that would be lasting," Dave says. was time to do our estate planning. We've always tried to be good stewards of our resources, and we've certainly taken to heart the advice of our friend Michael, a sustainable investments advisor, who reminded us that, "Money alone can't secure your future...it also requires investing in your community, your skill sets, your friendships, and the environment."\*

Our lifestyle, volunteering, and giving whatever financial gifts we could afford to local organizations have certainly affirmed that concept. And over the years as we became more versed in local land and water conservation efforts, supporting Door County Land Trust and its mission to preserve and protect Door County's land and waters was a natural fit. considered a planned gift for this place we love, the Land Trust was a fitting recipient.

We joked with our lawyer that we're not uber-rich, but we have certainly experienced blessedness; and since we don't have children as a legacy, we consider this part of our estate as a way of paying forward for Door County's future. It matters to us that the Land Trust is nurturing the next generation of conservationists by fostering their connections to the land and waters that the Land Trust protects. We trust our gift will help sustain this challenging task of protecting land and water in perpetuity.

### Your Legacy Gift will leave a lasting impact beyond your lifetime.

With so many giving options, please consult with your attorney or tax advisor about the various tax benefits and issues that apply to your personal situation. We are available to help facilitate these discussions and answer any questions you may have.

#### **Bequest Provision of Cash**

An outright gift of cash is the simplest way to give. When bequeathing cash, decide how much you wish to donate and have your attorney include your bequest to the Door County Land Trust in your will or trust.

#### **Retirement Plan Beneficiary**

- List DCLT as a beneficiary of your account
- Make DCLT a contingent beneficiary
- Give from your IRA

Leave a percentage or the entire amount of your retirement account to the Land Trust. By naming the Land Trust as the beneficiary, you avoid estate and income taxes on all amounts passing to the Land Trust. In many cases, a beneficiary of a retirement account would receive less than forty percent of the amount after tax, while the Land Trust would receive the entire amount.

#### **Charitable Gift Annuity**

Create a charitable gift annuity, which allows you to receive income during your lifetime, with the remainder benefiting the Land Trust.

#### Life Insurance Beneficiary Designation

A gift of life insurance has many advantages. This option is cost efficient, has tax benefits, and it's secure and confidential. You may give the entirety of an existing policy, retain ownership of an existing policy and name DCLT as a beneficiary, or purchase a new policy for future charitable gifts.

#### **Gift of Real Estate**

Giving through real estate offers incredible flexibility, as the following demonstrate:

- A direct gift of property through your will or living trust
- Donate your home but continue to live there
- Fund a charitable gift annuity with property
- Make a bargain sale of land
- Fund a FLIP Charitable Remainder Trust (Lifetime payments are sent to you or another named recipient after the property is sold. After death, DCLT receives the balance of the trust.)
- Establish a memorial or endowment gift

#### Charitable Trust

There are typically two types of trusts—a **Charitable Remainder Trust** and a **Charitable Lead Trust**. With the Charitable Remainder Trust, DCLT receives the remaining assets after your lifetime or term of years. The Charitable Lead Trust distributes the designated gift to DCLT first, with the remainder going to individuals of your choosing.

## **Directing Your Gift**

#### You may designate how your gift is to be used by the Land Trust by directing your gift to any of the following options:

#### **Option 1. Unrestricted**

Unrestricted gifts will provide the Door County Land Trust's Board of Directors with the flexibility to use the funds to meet the Land Trust's highest needs, including land acquisition expenses not covered by grants, land maintenance costs, unanticipated operating expenses, special project costs, or any combination of these costs. The Board of Directors also may designate all or a portion of such gifts to the Land Trust's Stewardship Endowment Fund.

#### **Option 2. Stewardship Endowment Fund**

You may direct your gift to the Stewardship Endowment Fund. All gifts to the Stewardship Endowment Fund will be held in perpetuity and will be available to fulfill the obligation of caring for Land Trust lands long into the future. Your gift directed to this fund will be invested and managed by the Door County Land Trust Endowment Board of Trustees. This Fund is structured to pay its annual income to the Land Trust to enable it to care for its lands, while at the same time growing principle through a conservative, professional investment strategy.

#### **Option 3. Land Acquisition Fund**

This special fund provides the Land Trust with a ready source of dollars to respond to immediate opportunities to purchase and protect properties of high ecological and scenic value.

#### Sample Bequest Language to Include in Your Will or Estate Plan

Once you choose to include a provision for the Door County Land Trust in your will or estate plan, you have many options for how to do so. A bequest is a personal decision, a statement incorporated into your will that you wish to have a certain portion of your assets given to the Door County Land Trust in your name. Properly constructed, a bequest can represent a considerable estate tax savings for your heirs and provide a legacy gift to Door County Land Trust. Several options are described here, though we encourage you to seek advice from your attorney or tax advisor regarding your unique situation and the latest guidance on taxes and estate laws.

### **Fixed-Sum Bequest:** A certain number of dollars, or shares of stock, or a parcel of real property is to be transferred. The bequest in your will might read:

I give the sum of \$\_\_\_\_\_\_\_ to the Door County Land Trust, Inc., a non-profit corporation organized under the laws of the State of Wisconsin, with a principal business address of P.O. Box 65 (217 N. 4th Ave., 2nd Floor), Sturgeon Bay, WI 54235, or its successor(s) in interest.

### **Fixed-Percentage Bequest:** Sometimes we are reluctant to name a specific dollar amount for a planned gift because we do not know what our family will need or what our resources might be in years to come. This type of bequest would state:

I give \_\_\_\_\_% of my gross estate to the Door County Land Trust, Inc., a non-profit corporation organized under the laws of the State of Wisconsin, with a principal business address of P.O. Box 65 (217 N. 4th Ave., 2nd Floor), Sturgeon Bay, WI 54235, or its successor(s) in interest.

### **Residual Bequests:** Sometimes we want to make specific provisions for individuals but then leave the remainder of our estate to charity. After naming the specific individuals and the amounts they are to receive, a residual bequest would read:

I give all the rest, residue, and remainder of my estate to the Door County Land Trust, Inc., a non-profit corporation organized under the laws of the State of Wisconsin, with a principal business address of P.O. Box 65 (217 N. 4th Ave., 2nd Floor), Sturgeon Bay, WI 54235, or its successor(s) in interest.

### **Event-Triggered Bequests:** Even with the best estate plan, you may find yourself in an unanticipated situation in which your named beneficiary might predecease you. It is possible to create a contingent bequest in which you would state:

If \_\_\_\_\_\_ (the named beneficiary) does not survive me, I give such share to the Door County Land Trust, Inc., a non-profit corporation organized under the laws of the State of Wisconsin, with a principal business address of P.O. Box 65 (217 N. 4th Ave., 2nd Floor), Sturgeon Bay, WI 54235, or its successor(s) in interest.

Making a planned gift to the Door County Land Trust can be an important part of your estate strategy. Please consult with your attorney or tax advisor about the various tax benefits and issues that apply to your personal situation.
